

COOKIE POLICY

1. About cookies

This website (further “Website”) and its content are property of and managed by Nutreco N.V. based at Stationsstraat 77, Amersfoort, the Netherlands and any company directly or indirectly owned or controlled by Nutreco that consumers, customers, suppliers and business partners (“you”) are interacting with or have a business relationship with (hereafter referred to as “we”, “us” or the “Company”). This Website uses cookies. A cookie is a small text file that we send to your internet browser so that we are able to recognize your browser when you return. Cookies can collect data on the use of the Website such as which pages are visited and the duration of a user session. When you use the Website, the cookie sends data to us. 2. We do not retain a cookie longer than necessary

We use session cookies and permanent cookies:

- A session cookie can track usage such as the webpages you visit and what options you use. When you close the internet browser, the session is ended and the cookie is deleted.
- A permanent cookie enables the Website to recognize you at a subsequent visit.

SKRETTING stores cookies that are essential in providing the functionalities of the Website. These cookies help us to collect data such as language preferences, webpages visited, and time spent on the Company’s website and other web traffic data. We use this data to improve services, analyze the activities and to personalize the individual’s experience. If you do not wish to receive any cookies at all, you may set your browser to refuse cookies all together and you are able to switch off cookies via the cookie banner on our website. Please note that in that case you may no longer be able to use all the functionalities of the Website.

3. Types of cookies

Besides cookies that are necessary for providing the functionalities of the Website, we place cookies that are not strictly necessary. Strictly necessary cookies are necessary for the website to function and cannot be switched off in our systems. Through non-strictly necessary cookies we collect information about your use of the Website and remember your preferences. Examples of collected information are which pages are visited, the length of a user session and browsing habits in order to make advertising relevant where data is shared with third parties. Through these cookies we aim to improve your user experience of our Website. Please see a summary all the cookies that the Company uses for the Website. We use four categories of cookies: ‘Functional’, ‘Preferences’, ‘Statistics’ and ‘Marketing’. If you do not consent to (one of these) or the functional session or permanent cookies described above, being placed, please change your settings.

Functional

cookies

These cookies are used to help make the website usable by enabling functions such as for the individual to move around the website. These cookies are required to let the website function. The data the Company collects is anonymized and therefore the Company cannot identify the individual. The legal ground for using functional cookies are based on legitimate interest.

Preference cookies

Preference cookies enable a website to remember information that changes the way the website behaves or looks, like your preferred language or the region that you are in. This improves your experience and makes your browsing simpler, easier and more personal to you. The legal ground for using functional cookies are based on legitimate interest.

Statistic Cookies

Statistic cookies help us to understand how visitors interact with websites by collecting and reporting information at an aggregated level. These cookies allow us to count visits and traffic sources, so we can measure and improve the performance of our site. The legal ground for using functional cookies are based on legitimate interest.

We will use Google Analytics' cookies. Google Analytics is a web analysis service that is offered by Google Inc. (Google). The Company has concluded a data processing agreement with Google to ensure proper protection of your personal data. The Company does not make use of any other Google services related to Google Analytics. To the extent allowed by the Google Analytics functionalities, the Company has opted out from sharing your information with Google. Google will remove the last three digits of your IP address. Google may only provide the aforementioned data to third parties if Google is required to do so by law, or to the extent third parties processing these data on behalf of Google. Marketing cookies (third party)

Marketing cookies are used to track visitors across websites. Marketing cookies contain tracking and targeting cookies. Tracking cookies are cookies that monitor how and when you visit our website. Targeting cookies collect information about browsing habits in order to make advertising relevant and allow you to share pages with social networks. The legal ground for processing personal data based on marketing cookies is your consent.

Third parties have the ability to place social cookies on the website of the Company and the Company is able to place cookies on a third-party website. Our advertising partners or other third-party partners use these types of cookies to deliver advertising that is relevant to the interests of individuals. These cookies can remember that a device has visited a site and may also be able to track the device's browsing activity on other sites or services other than ours. This information may be shared with organizations outside the Company, such as advertisers and/or advertising networks to deliver the advertising.

On some pages of our website the individual may see advertisements / cookies that are not related to the Company. When, for example the individual visits Facebook this third party may set their own cookie on the device of the individual and is then able to use our website to set this cookie. The Company does not have control over how these third-party cookies process personal data and is not able to access these cookies. Cookies can only be accessed by the party who originally set them. 4. How to control and delete cookies

An individual may want to delete any cookies that are already on the computer. Note that by deleting the Company's cookies or disabling future cookies the individual may not be able to access certain areas or features of the Company's site.

Please note that the Company cannot always control third-party cookies stored on the machine and that setting the individual's cookie preferences with the Company will not stop those third-party cookies from being stored on the machine. Therefore the individual must manage these cookies directly with the relevant third party.

5. Changes / updates

This cookie policy can change from time to time. The most up to date version is published on the website of the Company. We recommend to periodically read our cookie policy. If we process major changes to this policy individuals will be kept informed by a notification on our website.
